

Control Luciferase (GL4)

Specification : Deprotected, Desalted, purified (purity: > 95%), Annealed, Lyophilized **Form:** lyophilized (buffer added)

Dissolving Method : Add RNase-free Water to dissolve RNA oligonucleotides. Calculate the amount of water to add based on the table below. Final concentration of dissolved siRNA can be between 10μ M - 250μ M.

Annealing Buffer: 30 mM HEPES, pH7.4, 100 mM Potassium Acetate.

When you dissolve as the table below, buffer concentration will be 12 mM HEPES, pH7.4, 40 mM Potassium Acetate.

Notes :

- 1) The appearance of the sample can be transparent or in white powder form or have a yellowish tint. These differences have no effect on the quality of the sample.
- 2) Since the sample may have adhered on the lid or side of the tube during transportation, please be sure to spin down briefly upon arrival, before opening the lid.

Shelf Life and Storage conditions :

- 1) In dried lyophilized form, up to 6 months (4°C), 12 months $(-20^{\circ}C)$
- 2) After dissolving, up to 6 months $(-20^{\circ}C)$
- * After dissolving, in order to minimize freeze thaw, we recommend to aliquot the sample prior to storage. In addition, there shouldn't be any problems for about a week of storage at 4°C, when treated in RNase-free condition.
