## **Background**

Small GTP-binding proteins (or GTPases) are a family of proteins that serve as molecular regulators in signaling transduction pathways. Ral, a 24 kDa protein of the Ras superfamily, regulates a variety of biological response pathways that include vesicle trafficking, cytoskeletal rearrangment, and migration. The Ras-like proteins RalA and RalB share 85% identity. Like other small GTPases, Ral B regulates molecular events by cycling between an inactive GDP-bound form and an active GTP-bound form. In its active (GTP-bound) state, Ral B binds specifically to the protein-binding domain (PBD) of RalBP1 to control downstream signaling cascades.

### **Purity and Activity**

Cell Biolabs' rRal B is expressed and purified from *E. coli* as a recombinant protein with purity >90% by SDS-PAGE. It has an approximate MW of 25.8 kDa including a His-tag at the N-terminus.
