## Source

SARS-CoV-2 Spike RBD, His Tag (BA.4&BA.5/Omicron) (SPD-C522r) is expressed from human 293 cells (HEK293). It contains AA Arg 319 - Lys 537 (Accession # [QHD43416.1](#) (G339D, S371F, S373P, S375F, T376A, D405N, R408S, K417N, N440K, L452R, S477N, T478K, E484A, F486V, Q498R, N501Y, Y505H)). The spike mutations are identified on the SARS-CoV-2 Omicron variant (Pango lineage: BA.4 and BA.5; GISAID clade: GRA). Predicted N-terminus: Arg 319

## Molecular Characterization

This protein carries a polyhistidine tag at the C-terminus.

The protein has a calculated MW of 26.7 kDa. The protein migrates as 33-36 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.

## Endotoxin

Less than 1.0 EU per  $\mu$ g by the LAL method / rFC method.

## Purity

>95% as determined by SDS-PAGE.

## Formulation

Lyophilized from 0.22  $\mu$ m filtered solution in PBS, pH7.4 with trehalose as protectant.

## Storage


For long term storage, the product should be stored at lyophilized state at -20°C or lower.

This product is stable after storage at:


- -20°C to -70°C for 12 months in lyophilized state;
- -70°C for 3 months under sterile conditions after reconstitution.

## SDS-PAGE



SARS-CoV-2 Spike RBD, His Tag (BA.4&BA.5/Omicron) on SDS-PAGE under reducing (R) condition. The gel was stained with Coomassie Blue. The purity of the protein is greater than 95%.

## SEC-MALS



The purity of SARS-CoV-2 Spike RBD, His Tag (BA.4&BA.5/Omicron) (Cat. No. SPD-C522r) is more than 85% and the molecular weight of this protein is around 34-44 kDa verified by SEC-MALS.






## Background

It's been reported that Coronavirus can infect the human respiratory epithelial cells through interaction with the human ACE2 receptor. The spike protein is a large type I transmembrane protein containing two subunits, S1 and S2. S1 mainly contains a receptor binding domain (RBD), which is responsible for recognizing the cell surface receptor. S2 contains basic elements needed for the membrane fusion. The S protein plays key parts in the induction of neutralizing-antibody and T-cell responses, as well as protective immunity.
