Source

Biotinylated SARS-CoV-2 Spike RBD Protein (K417N, L452R, T478K), His,Avitag (SPD-C82Eg) is expressed from human 293 cells (HEK293). It contains AA Arg 319 - Lys 537 (Accession # [QHD43416.1](#) (K417N, L452R, T478K)). The mutations K417N, L452R, T478K were identified in the SARS-CoV-2 Delta sub-lineages (Pango lineage: AY.1/AY.2/AY.3; also known as "Delta Plus").

Predicted N-terminus: Arg 319

Molecular Characterization



This protein carries a polyhistidine tag at the C-terminus, followed by an Avi tag (Avitag™).

The protein has a calculated MW of 28.3 kDa. The protein migrates as 35-40 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.


Labeling

Biotinylation of this product is performed using Avitag™ technology. Briefly, the single lysine residue in the Avitag is enzymatically labeled with biotin.

Protein Ratio

Passed as determined by the HABA assay / binding ELISA.

Biotinylated SARS-CoV-2 Spike RBD Protein (K417N, L452R, T478K), His,Avitag on SDS-PAGE under reducing (R) condition. The gel was stained with Coomassie Blue. The purity of the protein is greater than 95%.

Purity

>95% as determined by SDS-PAGE.

>90% as determined by SEC-MALS.

Lyophilized from 0.22 µm filtered solution in PBS, pH7.4 with trehalose as protectant.

Storage


For long term storage, the product should be stored at lyophilized state at -20°C or lower.

Please avoid repeated freeze-thaw cycles.

This product is stable after storage at:

- -20°C to -70°C for 12 months in lyophilized state;
- -70°C for 3 months under sterile conditions after reconstitution.





Background

It's been reported that Coronavirus can infect the human respiratory epithelial cells through interaction with the human ACE2 receptor. The spike protein is a large type I transmembrane protein containing two subunits, S1 and S2. S1 mainly contains a receptor binding domain (RBD), which is responsible for recognizing the cell surface receptor. S2 contains basic elements needed for the membrane fusion. The S protein plays key parts in the induction of neutralizing-antibody and T-cell responses, as well as protective immunity.
