The spike mutations are identified on the SARS-CoV-2 Omicron variant (Pango lineage: BA.2.12.1; GISAID clade: GRA). Predicted N-terminus: Arg 319

# **Molecular Characterization**

This protein carries a polyhistidine tag at the C-terminus, followed by an Avi tag (Avitag<sup>TM</sup>).

The protein has a calculated MW of 28.4 kDa. The protein migrates as 34-38 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.

## Labeling

Biotinylation of this product is performed using Avitag<sup>TM</sup> technology. Briefly, the single lysine residue in the Avitag is enzymatically labeled with biotin.

Passed as determined by the HABA assay / binding ELISA.

### **Formulation**

Lyophilized from  $0.22~\mu m$  filtered solution in PBS, pH7.4 with trehalose as protectant.

### Storage


For long term storage, the product should be stored at lyophilized state at -20°C or lower.

- -70°C for 3 months under sterile conditions after reconstitution.


### **SDS-PAGE**

# Background

It's been reported that Coronavirus can infect the human respiratory epithelial cells through interaction with the human ACE2 receptor. The spike protein is a large type I transmembrane protein containing two subunits, S1 and S2. S1 mainly contains a receptor binding domain (RBD), which is responsible for recognizing the cell surface receptor. S2 contains basic elements needed for the membrane fusion. The S protein plays key parts in the induction of neutralizing-antibody and T-cell responses, as well as protective immunity.
