About FES

FES (feline sarcoma oncogene) is an enzyme that in humans is encoded by the FES gene. This gene encodes the human cellular counterpart of a feline sarcoma retrovirus protein with transforming capabilities. Non-onc intervening sequences were present in the human counterpart. The gene product has tyrosine-specific protein kinase activity and that activity is required for maintenance of cellular transformation. Its chromosomal location has linked it to a specific translocation event identified in patients with acute promyelocytic leukemia, but it is also involved in normal hematopoiesis. A truncated transcript has been identified that is generated utilizing a start site in one of the far downstream exons but a protein product associated with this transcript has not been identified.

Immunogen	A synthetic peptide corresponding to a sequence at the N-terminus of human FES, which shares 93.5% amino acid (aa) sequence identity with both mouse and rat FES.

Concentration	Adding 0.2 ml of distilled water will yield a concentration of 500 ug/ml.
Purification	Immunogen affinity purified.
Suggested Dilutions	Dilute the sample so that the expected range of concentrations fall within the detection range of this kit. If the expected range of concentration is unknown, a pilot test should be conducted to decide the optimal dilution ratio for your samples. 


Figure 1. Western blot analysis of FES using anti-FES antibody (A01453).

Electrophoresis was performed on a 5-20% SDS-PAGE gel at 70V (Stacking gel) / 90V (Resolving gel) for 2-3 hours. The sample well of each lane was loaded with 50ug of sample under reducing conditions.

Lane 1: human Hela cell lysate,

Lane 2: human 293T cell lysate,

Lane 3: human SK-OV-3 cell lysate,

Lane 4: human A549 cell lysate,

Lane 5: human MCF-7 cell lysate,

Lane 6: human placenta tissue lysate,

Lane 7: human PANC-1 cell lysate.

After Electrophoresis, proteins were transferred to a Nitrocellulose membrane at 150mA for 50-90 minutes. Blocked the membrane with 5% Non-fat Milk/ TBS for 1.5 hour at RT. The membrane was incubated with rabbit anti-FES antigen affinity purified polyclonal antibody (Catalog # A01453) at 0.5 ug/mL overnight at 4°C, then washed with TBS-0.1%Tween 3 times with 5 minutes each and probed with a goat anti-rabbit IgG-HRP secondary antibody at a dilution of 1:10000 for 1.5 hour at RT. The signal is developed using an Enhanced Chemiluminescent detection (ECL) kit (Catalog # EK1002) with Tanon 5200 system. A specific band was detected for FES at approximately 93KD. The expected band size for FES is at 93KD.
