# **Human Resistin PicoKine® Quick ELISA Kit**

#### **Assay Principle**

The Boster Picokine™ Human RETN Pre-Coated ELISA (Enzyme-Linked Immunosorbent Assay) kit is a solid phase immunoassay specially designed to measure Human RETN with a 96-well strip plate that is pre-coated with antibody specific for RETN. The detection antibody is a biotinylated antibody specific for RETN. The capture antibody is monoclonal antibody from mouse and the detection antibody is polyclonal antibody from goat. The kit includes Human RETN protein as standards.

To measure Human RETN, add standards and samples to the wells, then add the biotinylated detection antibody. Wash the wells with PBS or TBS buffer, and add Avidin-Biotin-Peroxidase Complex (ABC-HRP). Wash away the unbounded ABC-HRP with PBS or TBS buffer and add TMB. TMB is substrate to HRP and will be catalyzed to produce a blue color product, which changes into yellow after adding acidic stop solution. The density of the yellow product is linearly propotional to Human RETN in the sample. Read the density of the yellow product in each well using a plate reader, and benchmark the sample wells' readings against the standard curve to determine the concentration of Human RETN in the sample. # **Required Materials That Are Not Supplied**

Microplate Reader capable of reading absorbance at 450nm.

Automated plate washer (optional)

Pipettes and pipette tips capable of precisely dispensing 0.5 µl through 1 ml volumes of aqueous solutions.

Multichannel pipettes are recommended for large amount of samples.

Deionized or distilled water.

500ml graduated cylinders.

Test tubes for dilution.

# **Notice Before Application**

Please read the following instructions before starting the experiment.

- 1. To inspect the validity of experiment operation and the appropriateness of sample dilution proportion, pilot experiment using standards and a small number of samples is recommended.
- 2. Before using the Kit, spin tubes and bring down all components to the bottom of tubes.



- 3. Don't let 96-well plate dry, for dry plate will inactivate active components on plate.
- 4. Don't reuse tips and tubes to avoid cross contamination.
- 5. Avoid using the reagents from different batches together.


#### Human Resistin PicoKine® Quick ELISA Kit (FEK0581) Standard Curve Example

# Intra/Inter Assay Variability

# **Preparation Before The Experiment**

Item	Preparation
All reagents	Bring all reagents to 37°C prior to use. Also the TMB incubation time estimate (20-25min) is based on 37°C.
Wash buffer	Prepare 500 ml of Working Wash Buffer by diluting the supplied 20 ml of Wash Buffer (25 x) with 480 ml of deionized or distilled water. If crystals have formed in the concentrate, warm to room temperature and mix it gently until crystals have completely dissolved.
Biotinylated Anti-Human RETN antibody	It is recommended to prepare this reagent immediately prior to use by diluting the Human RETN Biotinylated antibody (50x) 1:50 with Antibody Diluent. Prepare 50 $\mu$ l by adding 1 $\mu$ l of Biotinylated antibody (50x) to 49 $\mu$ l of Antibody Diluent. Mix gently and thoroughly and use within 2 hours of generation.
Avidin-Biotin-Peroxidase Complex	It is recommended to prepare this reagent immediately prior to use by diluting the Avidin-Biotin-Peroxidase Complex (30x) 1:30 with Avidin-Biotin-Peroxidase Diluent. Prepare 400 $\mu$ l by adding 10 $\mu$ l of Avidin-Biotin-Peroxidase Complex (30x) to 390 $\mu$ l of Avidin-Biotin-Peroxidase Diluent. Mix gently and thoroughly and use within 2 hours of generation.
Human RETN Standard	It is recommended that the standards be prepared no more than 2 hours prior to performing the experiment. Use one 10 ng of lyophilized Human RETN standard for each experiment. Gently spin the vial prior to use. Reconstitute the standard to a stock concentration of 10 ng/ml using 1ml of sample diluent. Allow the standard to sit for a minimum of 10 minutes with gentle agitation prior to making dilutions.
Microplate	The included microplate is coated with capture antibodies and ready-to-use. It does not require additional washing or blocking. The unused well strips should be sealed and stored in the original packaging.

#### **Dilution of Human RETN Standard**

- 1. Number tubes 1-8. Final Concentrations to be Tube # 1: 5,000.00 pg/ml, # 2: 2,500.00 pg/ml, # 3: 1,250.00 pg/ml, # 4: 625.00 pg/ml,
  - # 5: 312.50 pg/ml, # 6: 156.25 pg/ml, # 7: 78.13 pg/ml, # 8: Sample Diluent serves as the zero standard (0 pg/ml).
- 2. To generate standard #1, add 500 µl of the reconstituted standard stock solution of 10 ng/ml and 500 µl of sample diluent to tube #1 for a
  - final volume of 1000 µl. Mix thoroughly.
- 3. Add 300 µl of sample diluent to tubes # 2-7.
- 4. To generate standard # 2, add 300  $\mu$ l of standard # 1 from tube # 1 to tube # 2 for a final volume of 600  $\mu$ l. Mix thoroughly.
- 5. To generate standard # 3, add 300  $\mu$ l of standard # 2 from tube # 2 to tube # 3 for a final volume of 600  $\mu$ l. Mix thoroughly.
- 6. Continue the serial dilution for tube # 4-7.



## **Sample Preparation and Storage**

These sample collection instructions and storage conditions are intended as a general guideline and the sample stability has not been evaluated.

Sample Type	Procedure
Cell culture supernatants	Clear sample of particulates by centrifugation, assay immediately, or store samples at -20°C.
Serum	Use a serum separator tube (SST) and allow serum to clot at room temperature for about four hours. Then, centrifuge for 15 min at approximately 1,000 x g. assay immediately or store samples at -20°C.
Plasma	Collect plasma using heparin or EDTA as an anticoagulant. Centrifuge for 15 min at approximately 1,000 x g. Assay immediately or store samples at -20°C.  *Note: it is important to not use anticoagulants other than the ones described above to treat plasma, for other anticoagulants could block the antibody binding site.
Cell lysates	Lyse the cells, make sure there are no visible cell sediments. Centrifuge cell lysates at approximately $10,000 \times g$ for 5 min. Collect the supernatant.

## **Sample Dilution**

The target protein concentration should be estimated and appropriate sample dilutions should be selected such that the final protein concentration lies near the middle of the linear dynamic range of the assay.

It is recommended to prepare  $150 \,\mu$ l of sample for each replicate to be assayed. The samples should be diluted with sample diluent and mixed gently.

# **Assay protocol**

It is recommended that all reagents and materials be equilibrated to 37°C/room temperature prior to the experiment (see Preparation Before The Experiment if you have missed this information).

- 1. Prepare all reagents and working standards as directed previously.
- 2. Remove excess microplate strips from the plate frame and seal and store them in the original packaging.
- 3. Add 50  $\mu$ l of the standard, samples, or control per well. And add 50 $\mu$ l of the prepared 1x Biotinylated Anti-Human RETN antibody per well. Add 50  $\mu$ l of the sample diluent buffer and 50 $\mu$ l of the prepared 1x Biotinylated Anti-Human RETN antibody into the control well (Zero well). At least two replicates of each standard, sample, or control is recommended.
- 4. Cover with the plate sealer provided and incubate for 60 minutes at RT.
- 5. Wash the plate 3 times with the 1x wash buffer.
- a. Discard the liquid in the wells into an appropriate waste receptacle. Then, invert the plate on the benchtop onto a paper towel and tap the plate to gently blot any remaining liquid. It is recommended that the wells are not allowed to completely dry at any time.
- b. Add 300 µl of the 1x wash buffer to each assay well. (For cleaner background incubate for 60 seconds between each wash).
- c. Repeat steps a-b 2 additional times.
- 6. Add 100 µl of the prepared 1x Avidin-Biotin-Peroxidase Complex into each well. Cover with plate sealer provided and incubate for 15 minutes at RT.
- 7. Wash the plate 5 times with the 1x wash buffer.
- a. Discard the liquid in the wells into an appropriate waste receptacle. Then, invert the plate on the benchtop onto a paper towel and tap the plate







to gently blot any remaining liquid. It is recommended that the wells are not allowed to completely dry at any time.

- b. Add 300 µl of the 1x wash buffer to each assay well. (For cleaner background incubate for 60 seconds between each wash).
- c. Repeat steps a-b 4 additional times.
- 8. Add 90 µl of Color Developing Reagent to each well and incubate in the dark for 30 minutes at RT (or 25-30 minutes at 37°C). (The optimal incubation time must be empirically determined. A guideline to look for is blue shading the top four standard wells, while the remaining standards remain clear.)
- 9. Add 100 µl of Stop Solution to each well. The color should immediately change to yellow.
- 10. Within 30 minutes of stopping the reaction, the O.D. absorbance should be read with a microplate reader at 450nm.

#### **Data Analysis**

Average the duplicate readings for each standard, sample, and control. Subtract the average zero standard O.D. reading.

It is recommended that a standard curve be created using computer software to generate a four parameter logistic (4-PL) curve-fit. A free program capable of generating a four parameter logistic (4-PL) curve-fit can be found online at: www.myassays.com/four-parameter-logistic-curve.assay.

Alternatively, plot the mean absorbance for each standard against the concentration. The measured concentration in the sample can be interpolated by using linear regression of each average relative OD against the standard curve generated using curve fitting software. This will generate an adequate but less precise fit of the data.

For diluted samples, the concentration reading from the standard curve must be multiplied by the dilution factor.

#### **Background on RETN**

Resistin is an adipose-derived hormone postulated to link adiposity to insulin resistance.1 Type 2 diabetes, characterized by target-tissue resistance to insulin, is epidemic in industrialized societies and is strongly associated with obesity. Adipocytes secrete a unique signalling molecule, which called resistin (for resistance to insulin), that may be the hormone potentially links obesity to diabetes.2 Resistin is overexpressed in human adipose tissue of obese individuals and is likely to modulate insulin sensitivity. Resistin is, therefore, a candidate gene for insulin resistance.3 The standard product used in this kit is human Resistin with the molecular mass of 51-53KDa. The detected Resistin includes zymogen and active enzyme.
