4. FIRST AID MEASURES**4.1 Description of first aid measures**

In case of Inhalation: Immediately relocate self or casualty to fresh air. If breathing is difficult, give cardiopulmonary resuscitation (CPR). Avoid mouth-to-mouth resuscitation.
