#### **SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS**

This product contains the following components and mixture of the following substances with non-hazardous additions.

Donor Plate: qty 1 Non-hazardous. Acceptor Plate: qty 1 Non-hazardous.

Dodecane: 1.5 mL Liquid

Contains 100% dodecane (CAS #: 112-40-3).

Lecithin: dried Non-hazardous.

High Permeability Control: 120 µL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5). Medium Permeability Control: 120 μL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5). Low Permeability Control: 120 µL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5).

### **SECTION 4. FIRST AID MEASURES**
