

SECTION 2. HAZARDS IDENTIFICATION

Colorimetric Probe (100X) (Part No. 284401): One 250 μL amber tube of solution

Classification:

Flammable liquids, Category 4 (H227) Acute toxicity, Oral, Category 4 (H302)



Hazard Statements: Combustible liquid (H227), Harmful if swallowed (H302).

SECTION 4. FIRST-AID MEASURES
