First-aid measures general

General measures: This product contains a material of biological origin. Use universal precautions during clean up procedures. Avoid breathing (vapor, mist). Use only in a well-ventilated area. Handle in accordance with good industrial hygiene and safety practice. Use personal protective equipment, see section 8.

For non-emergency personnel

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Methods and material for containment and cleaning up

Contain and collect spillage with non-combustible, absorbent material e.g., sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). 


