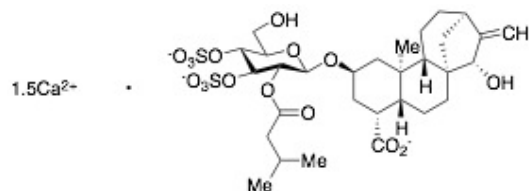

General Advice

Appropriate Engineering Controls
