

Unrated gloves are not recommended. Suggested gloves: AnsellPro Sol-Vex nitrile gloves style 37-175, 15 mil thickness. Penetration time has not been determined.

Gloves used for prolonged direct exposure (immersion) should be designated "chemical resistant" as per EN 734 with the resistance codes corresponding to the anticipated use of the material.

Suggested gloves: AnsellPro Viton/Butyl gloves style 38-612, 4/8 mil thickness. Penetration time has not been determined.

These recommendations may not apply if the material is mixed with any other chemical, or dissolved into a solution. A risk assessment must be performed to ensure the gloves will still offer acceptable protection.

#### **Body Protection**

Fire resistant (Nomex) lab coat or coveralls.

#### **Respiratory Protection**

Recommended respirators are NIOSH-approved N100 or CEN-approved FFP3 particulate respirators. These are to be only used as a backup to local exhaust ventilation or other engineering controls. If the respirator is the only means of protection, a full-face supplied air respirator must be used.
