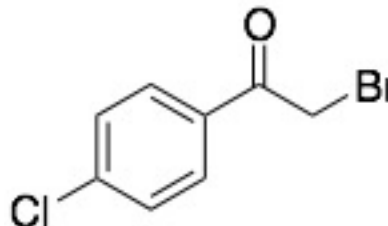

General Advice
