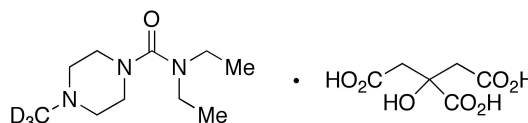

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

All recommendations below are advisory in nature and a risk assessment should be performed by the employer/end user prior to use of this product. The type of protective equipment must be selected based on the amount and concentration of the dangerous material being used in the workplace.

Eye/Face Protection

Skin Protection

Gloves should be used when handling this material. Gloves are to be inspected prior to use. Recommended respirators are NIOSH-approved N100 or CEN-approved FFP3 particulate respirators. These are to be only used as a backup to local exhaust ventilation or other engineering controls. If the respirator is the only means of protection, a full-face supplied air respirator must be used.
