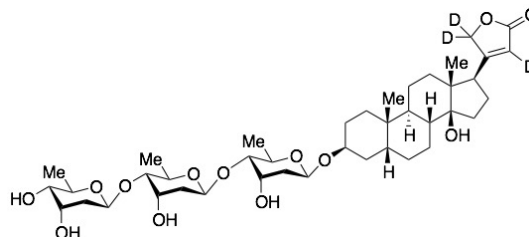

General Advice
