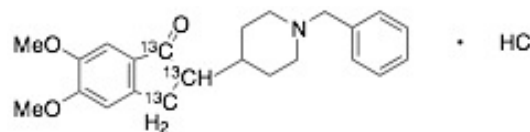

4.1 Description of First Aid Measures

General Advice

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

Eye/Face Protection

Skin Protection

Gloves should be used when handling this material. Gloves are to be inspected prior to use.
