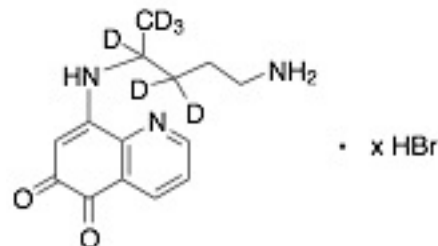

Appropriate Engineering Controls

Personal Protective Equipment

Eye/Face Protection
