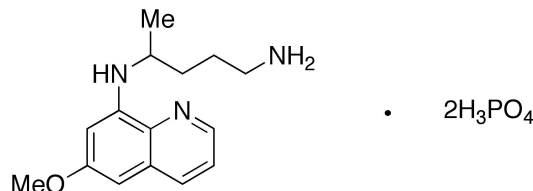

4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice

If medical attention is required, show this safety data sheet to the doctor.

If Inhaled

Appropriate Engineering Controls

Eye/Face Protection
