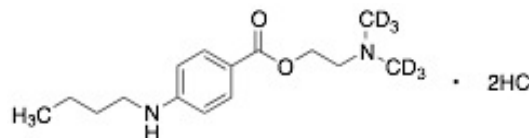

#### General Advice
