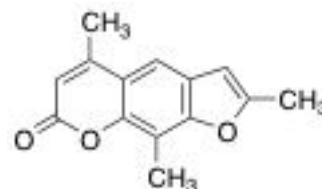

4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice

Appropriate Engineering Controls
