Section 2 : Product Composition (Classification)

The subject formulation is a blend of carbohydrates, inorganic salts. Phenol red is included as a pH indicator. After preparation in purified water, all ingredients are in concentrations of less than 1%.

Section 3 : Hazards Identification

Hazard: Not classified as hazardous. No exposure limits established by OSHA or ACGIH.

Section 4 : First - Aid Measures

In case of swallowing, wash out mouth with water provided person is conscious. In case of skin contact, flush with copious amounts of water for at least 15 minutes.
